- B. All notices, requests and other communications hereunder shall be in writing and shall be deemed delivered at the time of receipt if delivered by hand or communicated by electronic transmission, or, if mailed, three (3) days after mailing by first class mail with postage prepaid. Notices to Experian and AutoCheck Client shall be addressed to the address either party shall have designated.
- 20. Amendments. This Agreement may only be amended in writing signed by authorized representatives of both parties.
- 21. <u>Complete Agreement</u>. This Agreement, as supplemented by any Schedules, supersedes all prior except with respect to the billing method selected by the Client whether oral or written, by any officer, employee, or representative of either party relating thereto.
